## HOW TO GIVE A LEGACY GIFT TO EVANGELISM EXPLOSION

There are three options for you to leave a legacy to Evangelism Explosion

- **A share in your estate**
- **A specific sum**
- **A specific item**

Once you have decided what kind of gift you want to leave to Evangelism Explosion, it would be really helpful if you could ask your solicitor to use one of the following texts:

**Residuary legacy:** I give all/a share of (please state fraction/ percentage) of the residue of my estate absolutely to Evangelism Explosion, (Great Britain), Register office address 55 Rushendon Furlong, Pitstone, Leighton Buzzard, LU7 9QX, Registered Charity Number 269722, to be applied by Evangelism Explosion for its charitable purposes, and I further direct that the receipt of the Hon. Treasurer or any other proper officer of Evangelism Explosion for the time being shall be sufficient discharge to my executors.

**Pecuniary Legacy:** I give to Evangelism Explosion, (Great Britain), Register office address 55 Rushendon Furlong, Pitstone, Leighton Buzzard, LU7 9QX, Registered Charity Number 269722 absolutely, the sum of (amount in figures, amount in words) to be applied by Evangelism Explosion for its charitable purposes, and I further direct that the receipt of the Hon. Treasurer or any other proper officer of Evangelism Explosion for the time being shall be sufficient discharge to my executors.

**Specific Item:** I give to Evangelism Explosion, (Great Britain), Registered office address: 55 Rushendon Furlong, Pitstone, Leighton Buzzard, LU7 9QX, Registered Charity Number: 269722, absolutely, (write in here whatever you wish to give) to be applied by Evangelism Explosion for its charitable purposes, and I further direct that the receipt of the Hon. Treasurer or any other proper officer of Evangelism Explosion for the time being shall be sufficient discharge to my executors.

## WHEN IS A GOOD TIME TO CONSIDER MAKING MY WILL?

It's never too early to make a will, even today there are so many people who die without making a will, Please contact a solicitor who will be able to help you through the process of making a will, so you can be sure you have protected your estate and provided for your loved ones.

## CAN A GIFT TO CHARITY HELP ME PAY LESS TAX?

All Gifts made to UK registered charities are exempt from Inheritance Tax. We would strongly recommend that you speak to a solicitor for advice on tax issues.

## HOW WILL EVANGELISM EXPLOSION USE MY GIFT?

When we receive your legacy gift, we will put it to good use - helping as many people as possible hear the Good News about Jesus. You can also specify if you would like your gift to be used for a particular purpose and we will endeavour to act on your wishes.

## WHAT HAPPENS IF I NO LONGER WANT TO LEAVE A LEGACY GIFT TO EVANGELISM EXPLOSION?

Even if you have contacted us to let us know you plan to leave a legacy gift to Evangelism Explosion, you are still free to change your mind by altering your will. Should you change your mind, we would be very grateful, if you would take the time to contact us to confirm you have changed your mind.



<b>ESTATE:</b>	The property, including money, owned by the deceased, after any debts and/or expenses connected with his/her death have been taken into account.
<b>BENEFICIARIES:</b>	People or organisations – for example, a charity – who benefit from a will.
<b>TESTATOR:</b>	The person who makes the will.
<b>EXECUTOR(S):</b>	Person(s) appointed in a will by the testator to deal with the estate after his/her death.
<b>GUARDIAN(S):</b>	Person(s) appointed in a will by the testator to look after his/ her children, if there is no-one else with parental responsibility to do so.
<b>RESIDUARY</b>	A share of the estate (ie. a percentage) allocated in the will by the testator.
<b>LEGACY: PECUNIARY</b>	A gift of money (ie. where the precise value is specifically indicated) stated in a will.
<b>CONTINGENT LEGACY:</b>	A gift that is dependent on an event that may or may not happen. For example, if the testator outlives an intended beneficiary, gift might pass instead to a nominated charity.
